MEALS ON WHEELS SAN DIEGO COUNTY SERVES ALL OF SAN DIEGO COUNTY, INCLUDING THE 3,049 SQUARE MILES OF RURAL AND UNINCORPORATED AREAS. OF ALL SENIORS SERVED, 85% ARE CONSIDERED EXTREMELY LOW TO LOW INCOME ACCORDING TO THE 2023 INCOME GUIDELINES BY THE DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD). WE SUBSIDIZE MORE THAN 63% OF THE COSTS OF MEALS, DELIVERY, AND OTHER SERVICES PROVIDED, REGARDLESS OF A SENIOR'S ABILITY TO PAY. FURTHER SUBSIDIES ARE PROVIDED FOR SENIORS WHO ARE EXPERIENCING SEVERE FINANCIAL DIFFICULTIES.
