

Live Scan Pricing

Your total Live Scan cost has two parts:

1. **Our rolling fee - \$26**, charged for capturing and electronically submitting your fingerprints.
2. **The government agency fee(s)** - set by the California DOJ and, where applicable, the FBI or a specific licensing agency. This amount depends on *why* you're being fingerprinted, not on us - we collect it and pass it directly to the state/federal agency.
3. **If your requesting agency has a billing number all government agency fees will be charged to them directly. you will only be charged our rolling fee of \$26.**

Your total = \$26 rolling fee + the agency fee(s) for your purpose.

Below are the most common categories we process. If your purpose isn't listed, just ask - we'll confirm your exact fee before your appointment.
